


VENUE:

The global clinical trial market is estimated at US\$45 billion while the contribution by market in India is around US\$ 800 million only. While the US and Western Europe is dominating the market, accounting for more than three guarters of global revenues, the new study forecasts predict that market share for India will triple during the period 2011-2023.

Clinical trials market now witnesses a paradigm shift, Naive heterogeneous patient populations in the developing nations are opening up new avenues for the clinical trials market. Developing countries, like India also offer faster subject recruitment with significant reduction in trial costs, development in IT sector, availability of trained English speaking medical professionals, pharmacists and world-class accredited hospitals are triggering attributes for global pharma giants to direct their investment.

Challenges to Industry & Investigators: Now, health care administrators have a rather daunting task to comply with the ethical, scientific, regulatory issues and scrupulous documentation required for ensuring quality in overall clinical trial management. Safety, rights and welfare.

Supreme Court (India) recently said that unregulated clinical trials of new drugs were causing "havoc" in the country as it ordered the Health Ministry for strict vigilance resulting in promulgation of several legislative amendments for better protection of subject's safety, rights and welfare.

Role of Pharmacist: Today, Pharmacists are globally preferred candidates in the role of clinical research coordinator (CRC) for the conduct of trials and as clinical research associate (CRA) for clinical monitoring of ethical and regulatory compliance. In fact, Pharmacy Council of India (PCI) has commenced 6 year Pharm.D course which is predominantly clinical oriented. Their role is indispensable for patient recruitment, retention and quality assurance in clinical trials and pharmacovigilance activities.
